## Wisconsin EVV



In response to the federal 21<sup>st</sup> Century Cures Act, the Wisconsin Department of Health Services (DHS) is required to implement electronic visit verification (EVV) for Medicaid-covered home health care services (HHCS). DHS has received a good faith extension with the Centers for Medicare & Medicaid Services to implement EVV for HHCS by January 1, 2024. HHCS providers are not required to use an EVV system until DHS makes an official announcement on the ForwardHealth Portal.

DHS anticipates EVV being required for the service codes shown in the chart below. These are in addition to the four personal care and supportive home care service codes currently requiring EVV (T1019, T1020, S5125, S5126). Providers who use these codes will use EVV technologies to verify that authorized home health care services were provided. Workers will be required to use an EVV system to send information at the beginning and end of each visit, including the date, time, type, and location of services; the individual receiving the services; and the individual providing the services.
