New iCare Provider Portal

iCare launched a new and improved Provider Portal experience. The new Portal has more functionality for Office Managers and/or Administrators, in addition to other added features.

The <u>new Portal</u> is active for registration to be completed with information already at your disposal using your TIN, NPI and most recent check number. *i*Care can also generate a one-time PIN. If you have checks with 20 or more claims processed, you will need to register with a PIN. To request a PIN, <u>click here</u>. In your email, include your provider's name, TIN and NPI. You can also use this email to contact us with questions or concerns.

Prior Authorization List

*i*Care's Prior Authorization Department published a new <u>Prior Authorization List</u> which took effect June 1, 2022.

Many of the services requiring prior authorization are new service codes for 2022 as well as molecular pathology and genetic testing codes. Please remember to consult the prior authorization list before ordering send-out testing from reference labs.

When requesting prior authorization for any procedure or service, please include all pertinent clinical information including recent progress notes, therapy notes, pain scales, etc. While the Prior Authorization Department will attempt to request missing information whenever possible, *i*Care can provide faster determinations and avoid unnecessary denials when all the necessary information is included for review.
