- U07.2 COVID-19, virus not identified
- Clinically-epidemiologically diagnosed COVID-19
- Probable COVID-19
- Suspected COVID-19

Prior Authorization

Extending authorizations for a span of 90 days

Home Health/ Personal Care Workers

- Waiving supervisory visits

DME/DMS

- Waiving home assessments for certain items
- Waiving many requirements for replacement, lost, damaged equipment

Subacute Facilities when related to virus

- Waiving 3-day qualifying inpatient stay
- Waiving 60-day period between benefit


Place of Service (POS)

- Use POS 02

Physical/Occupational/Speech Therapy (PT/OT/ST)

Standard PT/OT/ST *cannot* be done via Telehealth as they are not considered remote providers.

PT/OT/ST can be done within the allowed telehealth codes

Telehealth Modifiers

- 95 Modifier
- GT Modifier

Place of Service (POS)

- Use POS 02

If billing for a Dual eligible iCare member, please use the GT modifier for both coverages to allow the claim to crossover to Medicaid

Physical/Occupational/Speech Therapy (PT/OT/ST)

PT/OT/ST can be done via Telehealth using the appropriate location code and modifier
